3. Bidder also has to pay the processing fess of **Rs.2500/-** according above to clause A.02
4. The bidders shall have to get themselves registered with E procurement and get user ID, password for Class — 3 and Class - 2. Digital signature is mandatory to participate in the e-tendering process.
5. Bidders who wish to submit online tenders can access tender documents on the website to fill it and submit the complete tender documents into electric tender on the website itself. Bidders shall attached scanned copies of all the documents as required fields in the bid.
6. The tenders without EMD will not be considered.
7. Corrigendum/addendum/correction. If any will be published on the website.
8. In the date of opening of tenders happens to be a holiday then the tenders will be opened on the next working day at same time or described by the committee.
9. The bidders are requested to submit the tenders well before the last date & time. Sugar mill will not be responsible for any Network or server failure, postal delay at the last moment of tender filling and hand over hard copy to address sugar mill.
10. The Sugar mill/committee reserves the rights to accept/reject/modify any or all tenders without assigning any reasons to bidders.

B. Terms and Conditions for Bidder

1. All the payment regarding bid documents in E- Tendering, will be through online mode NEFT/RTGS, Net Banking to **Shree Ganesh Khand Udyog Sahakari Mandli Ltd., Vataria**. EMD will treat as security money and shall be adjusted against the last consignment. No interest will be paid on EMD by sugar mill.
2. In addition to the technical details, the technical bid shall contain the proof of sales of the said materials and there working of past year.
3. The technical bids will be opened first, financial bids of the bidders whose technical bids are found to be responsive as per clause B1 & B2. Herein above shall be opened thereafter.
4. The rate should be FOR at Sugar mill without GST.
5. The price given in the tender must be valid for 60 days from date of opening of tenders.
6. Tenderers should be submitted strictly as per terms and conditions of the DNIT. Any deviation will result in rejection of tender.
7. Any dispute in respect of supply shall be in writing and made to the Sugar mill.
8. Sugar mill reserves the rights to accept/reject all tenders in case of any kind of action without assigning the any reasons to any tenderer.
